#### Who are we?

- 55 carriers representing 111 airline brands
- Part of a worldwide B.A.R. network





#### 2023 in a nutshell

- Air Traffic
  - Close to 170 million passengers
  - -5.5% compared to 2019 figures
- Weak Areas
  - French domestic -20.6%
  - Asia -21.9% (China -65.2%)
- Strong Growth
  - Africa +13.1%, mainly North Africa
- Main airports traffic
  - CDG -11.5%
  - ORY +1.4%
  - NCE -2.1%
  - MRS +6.8%
  - BVA +41.3%
- Total Movements
  - 3,133,200, -4.3% vs 2019





#### 2023 in a nutshell

- Annual average fare increase: +8.6% in 2023
- Fluctuations: Strong in the first half, more moderate in the second half
- Departing from France Mainland: +7.9%, driven by domestic (+13.6%) and international (+6.9%) networks
- Medium-Haul: Mixed changes, with increases from EEA & Switzerland and decreases to North Africa
- Long-Haul: Highest increases in the Middle East and Asia-Pacific, slower growth in North America





#### 2023 in a nutshell

Role of BAR France in 2023

- Administrative Support: Day-to-day assistance for airlines
- Representation: Involved in professional commissions, slot coordination, and administrative commissions
- Cost reduction initiatives: Actively participated in economic consultative commissions for major airports
- Civil aviation budget: Engaged in reducing airport charges and advocating for financial well-being of members
- Long-Term Action Environment
- Proactive participation in environmental discussions
- Focus on noise perimeters, balanced approach, IGMP, and air pollution working groups

  - Expected to reach 9.4 billion passengers (102.5% of 2019)
